General Rules for All Competitions

- Contestants must live in Solano County
- All applicants must have a registration form and **Release & Authorization to Participate Form submitted on or before the deadline of Monday, July 20th, 2009.**
- Minors under the age of 18 as of the day of the competition must have a signed Consent and Name Release authorization form on file with the Solano County Fair prior to the performance.
- There is no further competition scheduled or implied. These competitions are not affiliated with any other competitions.

Competition Specific Rules

Solano Stars:

- Solano Stars! Vocal Competition is for vocalists only. Duets, trios, bands, etc. are not eligible.
- Contestants may sing a-cappella or to professionally recorded tracks, which the contestant must supply on a CD. Lead vocals on the track must have been removed.
- Accompaniment by any form of live musical instrument is not allowed.
- Contestants may be any age.
- Songs containing explicit language are not allowed.
- Contestants will be judged on vocal talent, stage presence and entertainment appeal.

Talent/ Dance Competition:

- If a duo, trio or group is competing, cash prizes will not be awarded per contestant in the group, 1 cash prize will be awarded to the entire group.
- Songs containing explicit language are not allowed.
- Contestants may be any age.
- Explicit dancing is not allowed.
- Contestants will be judged on talent, stage presence and entertainment appeal.

Guitar Hero Competition:

- Contestants will compete at the highest level of the Guitar Hero game. The scores are automatically calculated by the game and the score(s) will be recorded.
- Contestants must be 18 & Under.
- All contestants will be able to play at least one game. If time allows, all contestants may play multiple times, and the highest score will be used. All contestants will be allowed equal playing time.
